Board of Commissioners Meeting July 5, 2023 7:00pm

The regular monthly Board Meeting for the Board of Commissioners was called to order by Board President; Steve Miller.

ROLL CALL

Board members present were Commissioners; Palladino, Valentine, Miller, Green, and Shawell, Also present was Township Manager; Debi Roesener, Township Secretary; Courtney Harris, filling in as Township Solicitor; Rich Almquist, Police Chief; Joseph Sokolofski, and Fire Chief; Frank Hand.

Ms. Roesener stated that it appears that this issue is on her property and is private. The Township didn't install these pipes, it use to be open drainage and previous owners may have done this work. Ms. Wade stated it isn't on her property and asked Ms. Roesener to reach out to her surveyor to clarify.
