- QMB (Qualified Medicare Beneficiary):
 Part B Premium, Medicare deductibles and copayments are paid for by the State of PA.
- SLMB (Specified Low-Income Medicare Beneficiary): the State of PA pays the Part B Premium only.
- QI-1 (Qualifying Individual): the State of PA pays the Part B Premium only.

- Meet the income limits listed below (assets are not counted as income).
- Income is based on prior calendar year.
- Medicare Part B Premiums are no longer counted as income.
