# Board of Commissioners Workshop Meeting January 17, 2024 7:00pm

The regular monthly Workshop Meeting for the Board of Commissioners was called to order by Board President; Steve Miller at 7:00 PM.

#### **ROLL CALL**

Board members present were Commissioners; Shawell, Valentine, Arms, Miller, and Green. Also, present was Township Manager; Debi Roesener, Township Secretary; Courtney Harris, Township Solicitor; Jamie Ottaviano, and Police Chief; Joseph Sokolofski. Absent was Fire Chief, Frank Hand.

#### MINUTES

Commissioner Green made a motion to approve the meeting minutes dated December 20, 2023, seconded by Commissioner Shawell, all were in favor of approving the minutes. Commissioner Shawell made a motion to approve the meeting minutes dated January 1, 2024, seconded by Commissioner Green, all were in favor of approving the minutes.

#### **PAYMENT OF BILLS**

Commissioner Green made a motion to approve the bill list as presented, seconded by Commissioner Shawell. All were in favor of approving the bill list.

#### **CITIZEN COMMENTS**

Frank Schultz – 518 W Race St. – Mr. Schultz expressed how unhappy he was that he was required to pay a trash bill for service he wasn't getting. He also stated how unhappy he was with the condition of the alley and how all kinds of screws and bottle corks are laying around from the trash company. After a brief discussion, Mr. Schultz was informed that the trash bill needs to be paid whether he is using the service or not because per Ordinance the Township is required to supply a trash hauler for the Township. He was also told that we are happy to address any issues or concerns such as the trash in the alley, he just needed to contact us, and we would send someone from J.P Mascaro out to address the issue.

#### **OLD BUSINESS**

Ordinance – Code – Chapter 19 – Sewer Lateral Definition Prepare for adoption – The legal ad to change the sewer lateral definition was advertised properly on December 22, 2023. Commissioner Arms made a motion to adopt the Ordinance, seconded by Commissioner Valentine. All were in favor of adopting the Ordinance.

#### **NEW BUSINESS**

Angelo's Cleaners – Conditional Use Hearing – Discuss/Render decision – Prior to this meeting there was a Conditional Use Hearing for Angelo's Cleaners. He is proposing four residential units on top of his commercial space. The property is cut in half with the front half being in the commercial district and the back half being in R3. It was Mr. Ottaviano's opinion that he saw no reason not to approve the Conditional Use for Mr. Pagnotti. Commissioner Green made a motion to approve the Conditional Use, seconded by Commissioner Shawell. All were in favor of approving the Conditional Use of the four residential units on top of the commercial space.
